- ☐ 3. Handwritten questions – You must legibly handwrite a one paragraph answer to each of the following questions. To qualify for a scholarship, students **must not use Chat GPT or any other artificial intelligence assistance program**. If it is determined that an artificial intelligence assistance program is used to answer the following questions, your scholarship application will be disqualified.

 - What are your plans as they relate to your education and career objectives and long-term goals?
 - What makes a cooperative business model different from other business models?
